Central District Board of Health returns to near-monthly meeting schedule for 2021

Meetings to be held virtually with online streaming and in-person viewing room available

Ada County, Idaho — The Central District Board of Health has set and posted its calendar year 2021 meeting schedule which will include eight regular business meetings. Meetings will be held on the third Friday of the month and start at 8:30 am with the first meeting of the year on Friday, January 15. The Board will no longer meet weekly as they have been most weeks since early July 2020 in response to COVID-19, however a special meeting can be called by any Board member at any time. If a special meeting is called, it will be publically noticed at least 24-hours prior to the meeting per Idaho Code 74-204(2) inside of CDH Headquarters at 707 N. Armstrong Place, Boise, ID 83704 and on the Board of Health Meetings web page at, <https://www.cdh.idaho.gov/about-boardofhealth-meetings.php>.
